## Head Judge Report WUSV World Championship IP in Hungary 2023

To start with, I would like to give thanks to the WUSV Board of Directors for having appointed me as head judge to the WUSV World Championship IP and for the trust they put in me.

The hosting country for this year's event was the *Magyarorszagi Nemet Juhaszkutya Klub - MNJK* from Hungary. After the Corona pandemic related cancellation of the event in 2020, a new event concept was developed, and a new venue had to be found.

The first visits to the venue and a pre-selection of the helpers were scheduled for the month of March 2023. In cooperation with the WUSV Commissioner for Trial & Training, Egon Gutknecht, we worked on the implementation and framework conditions of the competition. Mr. Mate Meszaros was put in charge to second us. He supported us very well and implemented our proposals as desired. I would like to use this opportunity give thanks to Mate Meszaros and his entire team. On all days of the event, sufficient and competent personnel was available.

Tracking judge was Mr. Vivi Gilsager from Denmark. Obedience was judged by Pierre Wahlström from Sweden as the main judge and by Ms. Ilona Fornal from Germany as co-judge. WUSV-Board of Directors member, Mr. Vadim Plotsker, from the United States was in charge of the down position of the dogs. The defense work was judged by the very experienced Toine Jonkers from the Netherlands. I would like to give thanks for the good and amicable cooperation.

Prior to the event, a total of 137 dogs was registered. Ultimately, at total of 123 dogs took part in the competition. After a five-day competition the winner was selected.

After a stunning performance, Marcos Ferre with Leo de Jardines from Spain did prevail.

Martin Pejsa with Chuck Felones from the Czech Republic gained the second place – closely followed by Janne Vaara with Airasuden Irck from Finnland on the third place.

Also, the team classification was won by the competitors from Spain.

The second place went to the founding country, Germany, right before the hosting club in Hungary.

Congratulations to everybody! I would like to also give thanks to the competitors for the fair and correct presentation of the dogs. By the same token, I would like to give thanks to the team captains for the good cooperation throughout the entire event.
