The WUSV member clubs are called up individually by the Secretary General. The congregation composed of the delegates and the board of directors consists of 195 votes out of 259 possible votes, and thus quorum is reached.

The WUSV member club of New Zealand sent Mr. John Fenner as a delegate to the assembly. Since Mr. Fenner is a citizen of Australia with no permanent residence in the country, he wishes to represent he cannot be admitted as a delegate with voting power. Thus, the assembly is represented with 194 out of 259 possible votes.

However, quorum is still guaranteed. The minimum number of votes would be 130.

1.5. Approval of the Agenda

The agenda of the WUSV General Annual Assembly 2019 is approved of by all authorized parties present. No additions are requested by the delegates. The president informs the party present that under TOP 6.3. a lecture shall be given by Dr Bernd Tellhelm. Also, the WUSV Board of Director in charge of breeding issues, Mr. René Rudin, will offer some explanatory statements in terms of the Breeding Program under item 6.2.

TOP 2) Minutes of the Meeting

The minutes of the meeting dated September 10, 2018 is unanimously approved of. No complaints were raised.

TOP 3) Annual Reports & Lectures

3.1. Report of the President

3.1.1. State of Affairs – FCI:

3.1.2. Options for WUSV Continental Directors – appointment of Associates for breeding, trail and training

3.1.3. Trademark Protection

Professor Meßler presents the above-mentioned items of the agenda. He refers to the issues pending which shall be solved in a stringent fashion in the future to come. In particular, he points out the situation in countries which are represented within the WUSV with two member clubs for German Shepherd Dogs. The foundation of an umbrella organization that unites the clubs in question shall be pursued. In case of lacking compliance future sanctions shall be imposed. In this connection, he once more quotes from the respective correspondence dated August 09th, 2019. The individual problems and resulting procedures are once again presented in detail.

Following this the above-mentioned procedure is voted on and unanimously approved of with no dissenting votes and no abstention.

Furthermore, he refers to the state of affairs in terms of public relations work within the WUSV which is not satisfactory for the time being. He assures the delegates that the issue will be addressed in a more consistent manner from now on in order to obtain the necessary improvements.

Also, Professor Meßler reports about the intention to obtain trademark protection for the evaluation VA – EXCELLENT SELECTION and points out the details in this respect.

3.2. Report of the Secretary General

Mr. Setecki reports about the working activities of the WUSV Secretariat General of the past year. No questions are raised.

From 10.00 hours on the delegates of the Royal Club du Berger Allemand de Belgique from Belgium join the assembly and as a result the number of valid votes increases to 195.

TOP 4) Finances

4.1. Report of the Cash Auditors

The cash auditor, Mr. Rodrigo González Campuzano, reports about the business year 2018, and comments upon the major items on the balance sheet. He furthermore reports that the *ATG Augsburger Treuhand – Augsburg Trust Company (ATG)* – carried out the orderly audit required. Mr. González Campuzano gives thanks to the WUSV Board of Directors and to the Secretary General for their work during the past business year, and requests the discharge of the WUSV Board of Directors for the business year 2018.

4.2. Audit Report 2018 & Economic Report 2018

The delegates received the business plan for the year 2019 as an attachment to the agenda. No questions are raised.

4.3. Discharge of the WUSV Board of Directors

Vote: The proposal is unanimously accepted by the delegates with no dissenting votes and no abstention.

4.4. Election of the External Auditors

Hitherto, the *ATG Augsburger Treuhand – Augsburg Trust Company (ATG)* – was in charge of the accounting of the WUSV. The secretary general proposes to continue the successful co-operation with the ATG. The proposal is unanimously accepted, with no dissenting votes or abstentions.

4.5. Contribution Payments/ Deposit Payments/ Admission Fees – State of Affairs

Mr. Setecki reports about the payments still pending from the member clubs in Greece, Moldavia (a partial payment was received, the payment of the balance was notified for the month of November 2019 and will be monitored by the finance department of the WUSV), Uzbekistan and Kyrgyzstan. The continental director in charge of the latter three countries, Ms. Elena Shchyra, will take care of the issue. Otherwise the membership fee account of the WUSV is balanced and no outstanding receivables exist.

From 10.15 hours on the delegates from the German Shepherd Dog Club of Pakistan join the assembly and as a result the number of valid votes increases from 195 to 199.

4.6. Budget Plan 2019

No questions are raised by the party present. The budget plan 2019 is unanimously approved of by the delegates.

4.7. Annual Review of Contribution Payments (proposal of the WUSV Board of Directors)

No adjustments are proposed by the board members.

4.7.1. Open Items – Receivables Membership Fees 2019

The item was already addressed.

TOP 5) WUSV Statutes – Changes & Amendments

5.1. § 16 Convocation of the General Assembly – Addition Paragraph 5 – Proposal by the WUSV Board of Directors

Old Version: non-existent

New Version:

Proposals of the same content can be submitted again at the earliest at expiration of three years for admission to the WUSV General Annual Assembly agenda.

Vote: The proposal is unanimously accepted by the delegates with no dissenting votes and no abstention.

TOP 6) Harmonization Procedure for worldwide breeding within the WUSV

6.1. WUSV Breeding Program – Version 2019

Recommendation:

The delegates to the SV Federal Assembly in 2019 recommend by one abstention, unanimously that the WUSV delegates to the General Annual Assembly accept the proposal under consideration of the following modification:

Breed Shows – Allocation of breed rankings subject to dental status

Regulation for ranking VA: deletion of „no double teeth“; exchange for “Double premolars 1 possible“

Vote: The proposal is unanimously accepted by the delegates with no dissenting votes and no abstention.

In addition to the agenda it is unanimously decided to implement the evaluation VA within the WUSV in accordance with the criteria described from January 01st, 2020 on. The officiating judges are to be informed about the formalities and requirements prior to the events and competitions they are supposed to judge.

In order to award the title VA – *Vorzüglich Auslese/ Excellent Selection* the following minimum requirements have to be met:

- *DNA (registered or verified)
- HD and ED: normal, almost normal or still admitted = fit for breeding
- IPO 1 or IGP 1 or Sch H 1 or SV recognized examinations – for existing VA a transitional period until 2020 applies*
- First Breed Survey examination with TSB pronounced
- TSB pronounced, drops and releases on the occasion of the qualification trial
- parents with breed survey and examination verified (KKL 1)

**according to its own country regulations*

Vote: The proposal is unanimously accepted by the delegates with no dissenting votes and no abstention.

6.2. Implementation formal requirements HD/ ED procedure & identification – DNA storage

Dr. Tellhelm presents the subject to the delegates and points out the future procedure. A publication on the WUSV homepage is scheduled for the end of calendar week 37. From that time on, participation in the program shall be possible. The WUSV member clubs will receive an additional notification by electronic mail in this respect. A couple of questions is discussed and answered.

TOP 7) Membership & Miscellaneous Proposals

7.1. Information Development Membership & Cooperation – Report by the WUSV Board of Directors Status Membership

The president points out the importance of the member clubs' cooperation and

contribution payments and kindly asks for consideration hereof. From now on, the ladies and gentlemen continental directors will be more actively involved in this field and provide support in terms of the collection of the data required.

7.2. Application for Junior Membership – Dominican Republic

The president of the Asociación de Criadores del Ovejero Alemán – ACOA RD, Mr. Pablo Peralta, presents his organization to the delegates and asks for admission within the circle of the WUSV member clubs as a junior member.

Vote: The proposal is unanimously accepted by the delegates with no dissenting votes and no abstention.

Thus, the Asociación de Criadores del Ovejero Alemán – ACOA RD is admitted to the community of the WUSV as a junior member from September 09th, 2019 on.

Mr. Roberto Caputi from Ecuador will serve as the club's mentor.

7.3. Application for Junior Membership – Jordan

The WUSV Senior Consultant, Mr. Clemens Lux, provides information in terms of the current situation in Jordan and informs the delegates that the German Shepherd Dog Club of Jordan can currently not be considered for membership since the organization is not yet a member to the national FCI club. However, a revaluation can be considered next year. The club in Jordan shall be informed accordingly by the WUSV Secretariat General.

7.4. Application for Full Membership – Mongolia

The president of the GSD Association of Mongolia, Mr. Soronzonbold Otgonzul, reports about the level of development of his club since the organization joined the WUSV in 2014, and kindly asks for admission as a full member.

Vote: The proposal is unanimously accepted by the delegates with no dissenting votes and no abstention.

Thus, the WUSV member club in Mongolia is a full member to the WUSV from September 09th, 2019 on.

Mr. Imran Husain continues to serve as the club's mentor.

TOP 8) Changes & Deletions WUSV Membership List

8.1. Due dates Contribution payments exceeded in 2019

The item was already addressed under topic 4.5.

8.2. Membership Status pending

8.2.1. Panamá – Report Roberto Caputi

Mr. Roberto Caputi informs the party present about the situation in that country. It is unanimously decided to offer the club members a chance to clarify their issues pending and decide about the continuation of their membership within the WUSV in particular and their activities in general. The issue will be put on the agenda again in September 2020.

8.2.2. Venezuela – Report Roberto Caputi

Mr. Roberto Caputi informs the party present about the situation in that country and Mr. Lux provides additional details. The WUSV Board of Directors decided to carry out a fundraising on the occasion of the WUSV General Annual Assembly. The party present is invited to make a voluntary contribution in this respect. The distribution of the amount donated shall be appropriated to a specific purpose.

Mr. Quoll presents the animals out of the working-class male dogs with the best results obtained on the occasion of this year's BSZ conformation show.

9.1.2. GHKL – Working Class Female Dogs: Helmut Buß

Mr. Buß reports about the conformation show and specifies upon the ratings of the animals out of the working-class female dogs.

9.2. WUSV Events since 2018

9.2.1. 31st WUSV World Championship 2018 in Randers/ Dänemark – Report Heinz Gerdes

Mr. Gerdes who served as head judge on the occasion of the WUSV World Championship 2018, provides a summary of the course of the event. No questions are raised.

9.2.2. 9th WUSV Universal Championship 2019 in Nantwich/ England – Report Egon Gutknecht

Mr. Gutknecht, who served as head judge on the occasion of the WUSV Universal Championship in Nantwich/ England likewise provides a summary of the course of the event. Furthermore, he offers a brief outlook on the World Championship 2020 in Hungary as well as the WUSV Universal Championship 2020 in France. Together with Mr. Rudin he briefly presents the first three winners of the competitions in Randers 2018 and Nantwich 2019.

Following this, Mr. Gutknecht presents a dashboard he worked on in terms of the contents of the newly issued IGP examination rules which will be made available free of charge in English and German on the WUSV homepage. The publication is scheduled for calendar week 39. No questions are raised.

In the meantime, the outcome of the fundraising for the WUSV member club in Venezuela has been calculated and amounts to 6,901.00 €. The final result will be published by the end of the campaign.
